With this consent, Dr. Shenk's office may mail or email to my home or other alternative location any items that assist the practice in carrying out TPO, such as appointment reminders, insurance forms or information, and patient statements. I have the right to request Dr. Shenk's office to restrict how it uses or discloses my PHI to carry out TPO. However, the practice is not required to agree to my requested restrictions, but if it does, it is bound by this.

By signing this form, I am consenting to Dr. Shenk's use and disclosure of my PHI to carry out TPO, I may revoke my consent in writing except to the extent that the practice has already made disclosures in reliance upon my prior consent. If I do not sign this consent, or later revoke it, I understand that I will be financially responsible for any dental work provided by this office.

FINANCIAL POLICIES:

Shenk Dental Care IS NOT AN IN-NETWORK PROVIDER.

Patients are expected to pay their expected portion of the procedure on the date of service via check or credit card. For patients with current PPO dental insurance, we will file a claim on your behalf. Most dental insurance plans do not cover 100% of our cost of treatment. We will estimate your portion as closely as possible using the information provided by your insurance company. THIS IS AN ESTIMATE and does not constitute an exact amount. This agreement is with YOU and not your insurance company. After 60 days, the balance will be due in full. After 90 days, a finance charge of 1.5% will be applied to the remaining balance monthly. **INITIAL** _____

Patients with outstanding balances over 180 days will have any upcoming appointments cancelled. Those appointments can be rescheduled once the balance has been paid in full. **INITIAL** _____

MISSED APPOINTMENTS:

At our office, we appreciate your valuable time and reserve an adequate time slot just for you, to be able to provide you the best service. For us to keep this level of service, we ask our patients to give us a minimum of 24 hours to cancel any appointment.

Please note that late cancellations/no shows will be subject to a \$75 missed appointment fee. Patients who have cancelled the same appointment 2 times may be asked to pre-pay their expected portion before rescheduling. **INITIAL** _____
